

PRIVACY NOTICE

In accordance with the provisions of the Federal Law on Protection of Personal Data Held by Private Parties (hereinafter "The Law") and its Regulations, we kindly request you to carefully read the terms and conditions contained in this Privacy Notice, as your mere provision of Personal Data and/or Sensitive Personal Data (hereinafter "Your Personal Data") constitutes acceptance of the following terms and conditions.

Proadmin Developer IX, S.A. DE C.V., and its subsidiaries (hereinafter "Proadmin") will be responsible for your Personal Data, in accordance with the provisions of Article 16 of The Law, with its registered address at Av. Santa Fe, 505, 5th floor, Cuajimalpa de Morelos, 05349, México City.

The terms Personal Data and Sensitive Personal Data shall have the meanings ascribed to them in Sections V and VI of Article 3 of The Law. The term Processing (hereinafter "Processing") shall have the meaning ascribed to it in Section XVIII of Article 3 of The Law.

The Personal Data you provide to Proadmin will be used for purposes including but not limited to:

USE OF DATA AND PURPOSE:

Your Personal Data will be used by Proadmin to identify you, locate you, communicate with you, contact you, send you information, hire you, for commercial prospecting, addressing doubts, clarifications, complaints, suggestions, requests, and claims, as well as for their transmission to third parties and/or allied companies through any means permitted by The Law. The use of your Personal Data will be directly related to the relationship you have as a consumer, client, supplier, or visitor. The period during which your Personal Data will be handled will be indefinite, starting from the date you provide them to Proadmin, unless you object to it at a time you consider appropriate;

PROCESSING

The Processing of your Personal Data, which has been made available to Proadmin in any form or circumstance, may be utilized by Proadmin in accordance with these terms and conditions. Henceforth, you explicitly authorize Proadmin to do so until you express your opposition through any of the means indicated by The Law;

To carry out the purposes described in this privacy notice, we may use the following personal data: Name, Marital Status, Tax Identification Number (RFC), Unique Population Registry Code (CURP), Place and date of birth, Nationality, Address, Home and mobile phone, Email, Autograph or electronic signature, Age, Photograph, Blood type, Job title or position, Work address, Institutional email and phone, Information generated during recruitment, selection, and hiring processes, Job training, Educational background, Degrees and Professional License, Certificates and awards, Bank accounts, Insurance, Hobbies, Social Security Number.

Who do we share your personal information with and for what purposes?

We inform you that your personal data may be shared with controlled, controlling, subsidiary, affiliated companies, investors, and financial institutions.

FRAMEWORK

You will always have the right to access the Personal Data that Proadmin has about you, for what purposes they are or have been used, and the conditions of use they are given ("Access"). Likewise, you have the right to request the correction of your personal information if it is outdated, inaccurate, or

incomplete (“Rectification”); to have it removed from Proadmin's records or databases when you consider that it is not being used properly (“Cancellation”); as well as to object to the use of your personal data for specific purposes (Opposition). These rights are known as ARCO rights.

To exercise any of the ARCO rights, you must submit the respective request through mail to the address of Proadmin or by email, which is as follows: info@interlogix.com.mx.

If you do not express your opposition to the transfer of your personal data, it will be understood that you have given your consent for it.

Regarding the procedure and requirements for the exercise of your ARCO rights, the following information is provided:

If you wish to exercise the rights of access, rectification, cancellation, or opposition regarding personal data that Proadmin has, you can do so by submitting your request in writing to the administration area designated for this purpose through the email info@interlogix.com.mx or at the address of Proadmin mentioned above, either in person or through courier, always identifying the owner through authentication mechanisms previously established by Proadmin.

The provision of information will proceed after verifying your identity or that of your legal representative, as applicable.

You can revoke the consent you may have granted to Proadmin for the processing of your Personal Data. However, please note that we may not be able to immediately address your request or conclude the use in all cases, as we may need to continue processing your Personal Data due to legal obligations. Also, you should consider that, for certain purposes, revoking your consent may result in Proadmin being unable to continue providing the service you requested or ending the relationship.

To revoke your consent, you must submit your request via Proadmin's email: info@interlogix.com.mx and correspondence to the aforementioned address.

DATA TRANSFER:

In the case of Sensitive Personal Data, you will have the right for Proadmin to inform you about any transfer that may be made to any third party, and for this purpose, you will be notified of such action by any means, whether written, telephone, electronic, optical, sound, visual, or any other that technology allows now or in the future. If this is the case, you have the right to oppose it, following the process mentioned in the immediately preceding point;

If Proadmin needs to use your Personal Data for purposes other than those indicated in this Privacy Notice, it will notify you in writing, by telephone, electronic means, or by any optical, sound, visual, or other means that technology allows now or in the future, and will explain the new uses it intends to give to such information in order to obtain your authorization; and

In the case of Sensitive Personal Data, you must provide Proadmin with your express and written consent for their Processing, through your handwritten signature, electronic signature, or any authentication mechanism established for this purpose and in accordance with what The Law establishes.

CHANGES TO THE PRIVACY NOTICE:

This Privacy Notice may undergo modifications, changes, or updates derived from new legal requirements, as well as from Proadmin's own needs due to modifications of any kind in the products or services offered by Proadmin, its privacy practices, changes in the business model, or any other cause.
